****JUNIOR MISS**

Ages: 8-11

Contest Date: Tuesday, August 22nd—immediately following Little Miss Junior @ 7:00pm

All Contestants are required to arrive at Fair Hall for Orientation no later than 6:00 pm.

Contestants will be asked to introduce themselves during the Pageant. Be prepared to state your parents or guardians name, what school you attend and your future ambition. (This will be the personality phase of your competition.)

Little Miss Contestants will be judged in a Long or Short Dress or Western Wear.

****MISS TEEN**

Ages: 12-14

Contest Date: Monday, August 21st– 7:00 pm

All Contestants are required to arrive at Fair Hall for Orientation no later than 6:00 pm.

Contestants will be asked to introduce themselves during the Pageant. Be prepared to state your parents or guardians name, what school you attend and your future ambition. (This will be the personality phase of your competition.)

Miss Teen Contestants will be judged in Formal Wear (after 5 or Prom Dress).

****MISS NORTH TEXAS FAIR & RODEO**

Ages: 15-18

Contest Date: Sunday, August 20th– 7:00 pm.

All Contestants are required to arrive at Fair Hall for Orientation no later than 6:00 pm.

Contestants will be asked to introduce themselves during the Pageant. Be prepared to state your parents or guardians name, what school you attend and your future ambition. (This will be the personality phase of your competition.)

Miss North Texas Fair & Rodeo Contestants will be judged in Formal Wear (after 5 or Prom Dress)

6. Orientation is mandatory for each contestant. We will be discussing the events of the evening, so please arrive at FAIR Hall at you designated time and date.
7. Contestants will receive their number during Orientation. Numbers should be pinned on the right side at fingertip level.
8. During Orientation, every possible effort will be made to let each Contestant practice prior to their competition.
9. Contestants will be judged in Three (3) Categories:
 - Poise 40%
 - Beauty 30%
 - Personality 30%
10. The Winners of each Division will receive a Trophy, Sash, and Bouquet of flowers. The Runner-Up of each division will receive a Trophy, Sash, and Bouquet of flowers. Little Mister will receive a Trophy and a Belt Buckle.
11. All Winners and Runners-Up are required to have their picture taken by the Official Fair Photographer. All Parents and Guardians are required to cooperate with the photographer in taking these pictures for the Association archives. All photographs become the property of the North Texas Fair & Rodeo and will be used for publicity and illustrations in publications.
12. All Winners are required to participate in the 2024 North Texas Fair & Rodeo Parade.
13. All Pageants are held in the DATCU Fair Hall Building.

RODEO EVENT AND/OR PRACTICE PARTICIPANT RELEASE AND INDEMNIFICATION AGREEMENT

_____, hereinafter referred to as "Participant", is executing this document voluntarily or, if participant is a minor, **has his/her**, hereinafter referred to as "his", **Parent or Guardian's**, hereinafter referred to as "Guardian", **express permission to participate in the Rodeo**. Participant/ Guardian states that participant is an experienced rodeo performer and in consideration of him being allowed to participate and/or practice he agrees as follows:

1. **PARTICIPANT/GUARDIAN AGREES TO INDEMNIFY AND HOLD NORTH TEXAS STATE FAIR ASSOCIATION, INC.**, hereinafter referred to as "FAIR", THEIR OFFICERS, DIRECTORS, EMPLOYEES, MEMBERS, AND VOLUNTEERS AND/OR AGENTS **HARMLESS AGAINST ALL CLAIMS, DEMANDS, DAMAGES, COSTS AND EXPENSES**, including reasonable attorney's fees for the defense thereof, arising from Participants', or his guests', or children's activities on or around the North Texas State Fair Association Grounds, hereinafter referred to as "Fair Grounds", at any time, **EVEN IF** the claim, demand, damage, cost or expense is **CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR**.

2. **PARTICIPANT/GUARDIAN FURTHER RELEASES THE FAIR FROM ALL LIABILITY** THE FAIR may otherwise owe to Participant, his heirs, survivors, beneficiaries, or assigns **FOR ANY PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH**, that Participant suffers while on the Fair Grounds, at any time, including but not limited to first aid, treatment or service rendered participant during participation in any Rodeo event and/or practice. This release applies to all injuries or damages which may be suffered by Participant, his heirs, survivors, beneficiaries, or assigns, **EVEN IF CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR**. This liability release also applies to claims and causes of action for injury to or the death of any of Participant's children.

3. **PARTICIPANT/GUARDIAN ACKNOWLEDGES THAT RODEO ACTIVITIES ON PROPERTY SUCH AS THE FAIR GROUNDS CAN RESULT IN INJURY** or property damage to the person engaged in those activities as well as others. The many possibilities and sources of injury or damage are acknowledged by Participant/ Guardian and Participant comes upon the Fair Grounds will full knowledge of such hazards. Participant/Guardian hereby gives his permission and consent to be transported to a hospital and given treatment by any doctor or hospital and his, her or its personnel.

4. The term "RODEO" in this agreement covers and includes all events taking place during the North Texas State Fair and Rodeo.

5. Participant/Guardian has read this document and understands its terms and conditions. Participant/Guardian is signing it freely and voluntarily. Participant/Guardian also releases any photographic image or video image to be used by the Fair as advertising or in promotion of the Fair and other events concerning the North Texas State Fair and Rodeo.
