THIS IS AN OPEN AIR VENUE. Fans will be in place, but bring your own personal,
battery operated fans if needed.



1. Eligibility – The show is open to Texas exhibitors only. No out-of-state birds will be permitted.
 - a. Youth may enter both open and junior shows provided separate fees and entry forms are submitted. Separate birds must be shown in each division. Youth may be ages 4-18 as of August 24, 2025
2. Absolutely NO late entries will be accepted. *Thank you for your understanding.*
 - a. State on entry whether entry is bearded or non-bearded and what type of comb when applicable.
 - b. Substitutes will be permitted when they are the same breed, sex, class and variety.
3. Judging will be by comparison with APA standards as appropriate.
4. All birds entered in competition will remain until the release time as announced by show officials. There will be no early releases unless approved by show superintendents.
5. No exhibitor or spectator will be permitted in the aisles where judging is in progress or in any manner interfere with the judges or attempt to influence the decision.
6. Club, Show Officers and Management shall have full authority to make any decisions necessary in order to conduct this show in an orderly and efficient manner.
7. Entry fee for Open and Junior \$5.00 per bird
 - a. Double coops are available for open show only but are very limited. Double coops will be \$10.00 and you must contact Laura by email for confirmation at (lcc.clark@gmail.com) prior to sending your entry if you need double coops.
 - b. Showmanship is \$5.00 per junior; prizes are buckles for showmanship. Notice: It is your responsibility to make sure that your bird is not about to be judged prior to removing it for the Showmanship competition. "Out for showmanship" signs need to be displayed so no one misses out on being judged in their bird class.
 - c. Showmanship will be conducted in accordance with the Youth Exhibition Poultry Association
 - i. Time slots will be signed up for - first come, first served - at the time check in.
 - ii. Age Classifications (as of show date): Pre-Junior (6 & Under) Intermediate (11-13), Junior (7-10), and Senior (14-18)
8. All entry fees, once received, are nonrefundable unless the show is cancelled.



9. The grounds will open to receive birds on Saturday, August 23, from 6:00 pm-8:00 pm.
 - a. On Sunday the barn will reopen at 7:00 am.
 - b. All birds must be in place by 9:00 AM, all exhibitors must be clear of the floor by 10:00 for judging to begin.
 - c. No person will be allowed in the aisle during judging or will be allowed to talk to the judge while he is judging except for Show Personnel.
10. Only judges and show officials are allowed to handle and move birds other than the owner.
11. Only healthy birds will be accepted at the show for exhibition. NO sick or diseased birds will be permitted to show. Sick birds will be removed from the show barn.
12. State regulations must be followed to attend this show. The NTFR does not provide testing services on the venue grounds.
 - o If an authorized testing agent volunteers to provide testing at the show, we will update as necessary.
13. All APA recognized breeds and varieties accepted. All others will be included in backyard class.
 - a. This show will be sanctioned by the American Poultry Association, and if numbers permit, the American Bantam Association. The rulebook will be update to reflect this change if made.
14. Exhibitors will be responsible for feeding and watering their own birds.
15. Scales will not be provided by the show for the weighing of birds.
16. All judges' decisions are final.
17. The club has the right to change or add judges as necessary.
18. NO EARLY COOP OUT! If you coop out early, you forfeit any and all prizes. NO Exceptions!
19. The North Texas Fair & Rodeo will not be responsible for any loss, accident or damage for any reason. Exhibit is the sole responsibility of the exhibitor.
20. The protest must be filled with the show committee along with \$250.00 cash, which will be returned if the protest is upheld.
